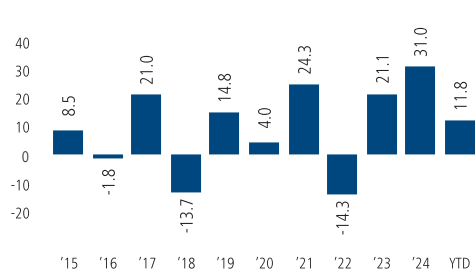

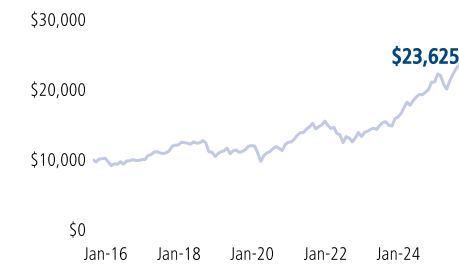

Concurrent with this change, Arup Datta assumed lead portfolio management responsibilities for the Fund.
